## Article 1 Objectives

## Article 2 Scope

This **PROTOCOL OF PARTNERSHIP** has the following scope:

- a) Work together to better the spiritual and technological human resources of both Institutions;
- b) Implement events aiming the development of competence to face the constant need of training potential candidates for the ministry;
- c) Exchange of technical and scientific information to benefit the partners and equip them for its utilization in the enhancement of their life and the lives of others;
- d) Increase competence and human resources [volunteers] towards more success in shared initiatives;
- e) Make effective use of information, sharing of audio/visual, paper and internet contents on events pertaining to the ministry. Public, audio/visual, papers and internet display/promotion of the Tchuma Tchato Project and Kingdom Life Worship [Community] Centre.
- f) Organization of courses, seminars and workshops whenever/wherever suitable;
- g) Any other actions the partners will deem useful for the purpose of the ministry.

## Article 3 Actions

- a) The scope of cooperation in the previous article, as well as other actions considered of mutual interest will be carried out by one of the partners, following consensual planning, which will be noted in autonomous documents, protocols and subsequent partnerships.
- b) All activities carried out within this **PROTOCOL OF PARTNERSHIP** must have the partners demographics needs as their main objective.

## Article 4 Schedule

- a) This **PROTOCOL OF PARTNERSHIP** will become effective when signed and will be in effect while the partners consider it useful for the development of the objectives previously enunciated.

## Article 5 Termination of the Protocol

- a) The non compliance by one of the parties to the regulation in this **PROTOCOL OF PARTNERSHIP** will grant the other party the right of termination.

b) The termination shall be notified to the faulty partner by means of a registered letter and/or email, taking effect upon reception.
